KEEPING IT LEGAL



IT'S THAT TIME OF THE YEAR AGAIN...

The IRS has started accepting and processing Taxes for the 2021 Tax Year. The federal deadline for submission is April 18, 2022.

Where do I begin?

Start by gathering your documents

Common documents include:

- a. W-2: Employment Income
- b. Other miscellaneous income, including retirement income
- c. Deductions, including mortgage interest; charitable contributions; and student loan interest
- d. Form 1095: Health Care Info
- e. Social Security Numbers

How do I file?

In person?

Military Gold Star families are eligible for tax services at the Soldier Support Center, First Floor, Wing D. For an appointment, call the Survivor Outreach number (910-396-9901) or walk-in. Office is open from (0900-1600).

What if I am deploying?

If you are an eligible member (AD/Reserve) and served in a designated combat zone during the applicable tax year, you may qualify for INCOME TAX EXCLUSION.

What is excluded?

-Basic pay -Imminent danger/hostile fire pay

-Re-enlistment bonuses -Discharge benefits

-School Loan repayments -Awards/financial incentive

Filing Deadlines:

If you are deployed, you can get 2-month extension if your tour of duty includes the filing due date or you can get an additional 4-month extension by filing IRS Form 4868 by June 15 (see "How Do I File" above).

If you are serving in a combat zone, your deadline is extended for 180 days after your last day of service in a combat zone. When you are calculating the new deadline, add the number of days you had to take action when you entered into the combat zone (i.e., if you had 30 days to file when you started serving in a combat zone, you will have 180+30 days to file when you leave the combat zone).

ETHICS CORNER

Today's Topic: Endorsement

Did you know that advertising support of other outside agencies could be an ethical violation?

Government employees cannot use their DoD position or title in a manner that could be construed to imply that the Government supports said activities.

To prevent this, not only should you reach out to our office, but you should also avoid using words such as "endorse" "support" "encourage" "recommend" or "urge."
