TAX UPDATES

1. **FILING DEADLINE EXTENDED:** The IRS has extended the TY2020 tax filing deadline to 17 May.

NC also extended their deadline to 17 May. Penalties for late payment and/or late filing will not begin until 18 May. Interest would accrue on any balance due beginning on 16 Apr.

Check with your individual state for updates.

2. **PPE DEDUCTIBLE:** Amounts paid for certain Personal Protective Equipment treated as medical expenses. See Announcement 2021-7

3. **NEW CHARITABLE DEDUCTION ALLOWANCE.** Taxpayers who don't itemize deductions can take a charitable deduction of up to \$300 for cash contributions made in 2020 to qualifying organizations. For more information, people should review IRS Publication 526.

OFF DUTY EMPLOYMENT

Air Force personnel should inform their supervisor prior to engaging in any kind of outside employment.

Most installations, including Pope AAF, have a local or command policy that requires individuals to complete an AF IMT 3902, *Application and Approval for Off-Duty Employment*.

The application is available on-line and must be reviewed and approved by your supervisor, and then forwarded to legal for review prior to starting your 2nd job.
